Job Description

Title: Community Navigator Salary: \$21 - \$28.00

Reports to: Director of Strategic Program Development Classification: Full time Hourly, Non-Exempt

Position Summary: Community Navigator plays a crucial role in helping individuals and families access and navigate health care coverage programs, specifically Cal-Fresh, Medi-Cal, and Covered California. They are responsible for outreaching to community residents, helping individuals and their families understand their medical options, determine eligibility, and assist with redetermination services, Cal-Fresh, and Medi-Cal enrollment. Community Navigator is responsible for meeting projected goals, coordinate outreach & enrollment efforts by working collaboratively with other and community- based organizations.

Responsibilities:

Day-to-day responsibilities include, but are not limited to, all the essential functions listed below:

- 1. Assist clients enroll into eligible health plans, gather required documentation. .
- 2. Schedule appointments with applicants and screen them for eligibility obtaining required information, such as employment information, income, and other information as needed to complete enrollment.
- 3. Assist applicants to facilitate accurate completion of application(s) and successful enrollment/re-enrollment to Cal-Fresh and Medi-Cal programs.
- 4. Attend community events such as health, community and resource fairs hosted by CalOptima Health and community stakeholders to provide redetermination services and Cal-Fresh and Medi-Cal enrollment.
- 5. Actively collaborate with key community based organizations including Family Resource Centers, shelters, and ethnic markets, to provide on-site redetermination services and Cal-Fresh and Medi-Cal enrollment.
- 6. Maintains a database of healthcare and other enabling services available with data collection on availability and eligibility requirements for client information.
- 7. Participates in planning discussions and meetings to support outreach and enrollment goals.
- 8. Participates in outreach and community events, as assigned.
- 9. Perform fieldwork and travel to community events to reach clients and interact with the community in a culturally and linguistically appropriate manner.
- 10. Remain current with community resources and make referrals as appropriate.
- 11. Perform other related duties as assigned.

Skills/Qualifications:

- Meets the State of California Certified Enrollment Counselor requirements and is in good standing.
- Knowledge of eligibility requirements and application process of health insurance programs Ability to take initiative to identify and propose new tasks and procedures.
- Ability to establish and maintain working relationships with a diverse group of staff, public and professionals.
- Ability to manage time, prioritize task and meet deadlines.
- Communication skills both verbal and written, with the ability to work independently and collaboratively as needed.
